- VII. in the event a court finds any part of this Release unlawful and/or unenforceable, the remaining parts of this Release shall remain in full force and effect;
- VIII. any legal action or claim not barred by this Release shall be restricted to the jurisdiction of Palm Beach County, Florida; and
- IX. this Release shall be legally binding upon the Participant, and the Participant has carefully read and understood its contents, including the release of certain legal rights, before voluntarily signing below.
